3. The Host will pay the Facilitator **70% of NET proceeds** from workshop and private sessions, with the option to negotiate further payment for additional services. The Facilitator will be given an initial amount of **\$300 for deposit to lock in date**. The Facilitator will receive the additional balance at the completion of the event, minus the deposit.
4. In addition to event design, Facilitator's duties will include but not be limited to **assisting with marketing and promotion, print and radio interviews**.
5. Necessary lodging/travel costs incurred by the Facilitator **will** be covered by the Host.
6. The Facilitator agrees to use Host's company logo and no other where desired.
7. The Host agrees to acknowledge the Facilitator's services in **all marketing materials** including the Facilitator's logo.
8. The Host will not enter into any contracts on behalf of the Facilitator or without the Facilitator's knowledge and consent.
9. If the Host cancels within **30 days** of the event they will be refunded **75%** of the original fee. If the Host cancels within **20 days** of the event they will receive **50%**, and after **7 days** no refund will be given.
10. If the Facilitator cancels, **he** will either provide a substitute planner or refund the full fee, minus the cost of nonrefundable deposits.
